 - iii. Programme of study being undertaken, clearly showing enrolled papers.
 - iv. Year of study.
 - v. Signed and dated by the Registrar or Head of Department.
- 4.6 **Academic Record.** If you are in the 2nd year or higher of your programme of study, please include a copy of your results/academic record for each year of study. First year tertiary students please provide a copy of your most recent school results/records.
